II. Board of Health Candidate Interviews

Health Director informed the Board that there is an opening on the Board to finish out the 2020 term previously held by Paul O'Bryan.

Health Director then introduced first candidate Eric Weston. Board Chair, Hillard Boskey gave a background and expectations of Board members. The Health Director advised that he had met with Mr. Weston and had gone over the wide range of issues that the Board addresses. The Board Chair then asked Mr. Weston about his qualifications and interest in serving on the Board. Mr. Weston responded that he has a degree in Environmental Studies from The State University of New York, in Cobleskill New York. Currently resides in the town of South Yarmouth and would like to create more of a presence in the community. He serves as Direct Support for the Capeabilities Farm at this time with a background in Agriculture pertaining to soil and water conservation. The Chair asked Mr. Weston if he was able to make monthly meetings and if he had any conflicts of interests. Mr. Weston responded he can make non bias decisions for town benefits and saw no issues with making monthly meetings. The Chair thanked Mr. Weston for his time and adjourned the interview.

Health Director then introduced the next candidate Dr. David Sheinkopf. Board Chair, Hillard Boskey gave a background and expectations of Board members. The Chair asked Dr. Sheinkopf about his qualifications and interest in serving on the Board. Dr. Sheinkopf responded that he has 50 years of service to community through organization such as The Yarmouth Food Pantry & The Rotary Club. Stated his desire to become more involved within the community and his concern of communicable diseases. Informed the Board that he does travel a lot and there may be an issue of getting to all Board meetings due to these travels however he could try to arrange his schedule to make most meetings. The Chair asked if Dr. Sheinkopf had any conflict of interests at which Dr. Sheinkopf stated no. The Chair thanked Dr. Sheinkopf for his time and interest then adjourned the interview. The Chair asked each Board Member to place nomination in an envelope. Chair indicated all ballots noted Eric Weston as member's choice.

III. Protect Our Cape Cod Aquifer- POCCA

The Health Director informed the Board of The Selectmen's request to limit Round-Up uses on town property. The Board asked what other towns and departments were using on town properties. The Health Director informed the Board that there is a scheduled meeting January 17, 2019 of the Conservation Department. He also informed them that an e-mail has been sent to Golf, DPW & Recreation for feedback on this issue. Vice Chair stated she would like to hear from all departments prior to The Board making any decisions on the matter. Goal is to get rid of all pesticides though these pesticides seem to be the only products that work on weeds, phragmities and poison ivy.

IV. Hearing – Baskin's Ace Hardware, 23 White's Path, Units I, J, K

Vice President of Baskin's Ace Hardware, Lynn Colagione came before the Board with a proposal to expand their current store footage and enlarge their paint department. The existing business is grandfathered in under the health Departments Hazardous Material Regulation. As the store was there prior to the regulation. She explained to the Board that it would be more than just the paint department expanding. The electrical, plumbing and showroom areas would also expand once the paint department was relocated. Their Harwich store has already undergone the expansion and has had warm reviews from locals. The Board expressed concerns of more Hazardous & toxic material being added to the location. Ms. Colagione stated most of their paint products are water based which are less hazardous. Vice Chair asked Carl Lawson, Hazardous

Waste Inspector, if inspections have been made. He responded that Baskin's Hardware is very timely with their permits and all inspections conducted were up to code. Conditions of this expansion were laid out by Mr. Lawson to Baskin's Vice President and Store Manager, David DeCenzo. These conditions were understood and agreed upon by all parties.
